All the lakes within the Domaine are private and are not open to public access. This year the gate at the Lac Bataille boat launch will be closed to coincide with the trout fishing season i.e. April 24 to September 13. If you need to launch and/or take out your boat during this period please call one of the persons listed below. However, before calling please go through this checklist:

- out of courtesy to the volunteer with the key, please make arrangements 24 hrs in advance
- if you are not a member of PSLL each time the gate is unlocked you will be requested to pay a \$10.00 service fee in cash.
- Paid up members are admitted free of charge
- NO PERSONAL WATER CRAFT (SEA DOOS) can be admitted/launched
- CHECK YOUR BILGE WATER and EMPTY IT BEFORE YOU REACH THE LAKE! You can contaminate our lake water with problems such as milfoil which you innocently picked up elsewhere.

YOU DON'T EXPECT FREE COFFEE SO WHY EXPECT FREE BENEFITS WITHOUT MEMBERSHIP?

YOUR PROPERTY IS DEFINITELY WORTH 11 CENTS PER DAY

We are working hard to increase our membership and to have ALL owners join the Association so that they can enjoy the benefits that we offer fairly. Why fairly? Well if a property owner pays taxes, he/she rightfully expects to benefit from opportunities and services such as the municipal vote, education, garbage collection, roads maintenance, fire protection etc. If taxes are not paid the municipality takes action and all property owners understand - its fair! As the expression goes - "there is no free coffee".

So why should a property owner expect to benefit from services that PSLL offers without contributing to them and supporting them? It's NOT FAIR nor is it RIGHT! PSLL membership fees, for example, pay to test water quality annually, to stock the lakes with trout and help maintain our private roads which access the majority of our residences. Why should a non-paying owner benefit from water quality information, eat and fish the lakes and drive the roads without contributing? It's NOT FAIR and it's NOT RIGHT. THERE IS NO FREE COFFEE!

In 2008 only 278 of your neighbours of a total of 492 owners joined the Association PSLL and paid their annual membership fee for a 56.6 percentage of paid members. This compares to 44% in 2006, and 58 % in 2007. Even though we have somewhat maintained the increase in membership, there are too many owners who are having a free ride.



RECYCLABLE MATERIALS

ACCEPTABLE

- All paper products, metal containers, bottles and glass, plastics of all kinds (containers and bags), cans of all kinds, aluminum. Everything must be clean.



NOT ACCEPTABLE

- No other materials are accepted such as garbage, construction materials, dangerous household products, tires, paint, oil,

PROTECT YOUR GARBAGE FROM ANIMALS

SO WHAT'S NEW WITH OUR ENVIRONMENT? What has PSLI been up to on your behalf to protect and promote our collective paradise?

Shoreline Visitation Program

This program began two years ago when the Federation of Lakes of Val -des- Monts (FLVDM) received funding from the municipality of Val-des-Monts and Environment Canada's "EcoAction" initiative. In the first year Lake St-Pierre was targeted by the program and in year two was Lake MacGregor. Also, last year the program was expanded to cover our area. In 2009 the program's activity will be on Grand Lake and will also be open to interested parties for the shoreline in our domaine. Your Association has lobbied hard to have this happen. So what is this program all about?

The program offers owners a free home or cottage visit by a biologist who provides information on good environmental practices. The biologist will also suggest appropriate changes to the owner through a personalized plan aimed both at ecological improvement to the shoreline and protection against erosion. Not only does the plan include recommendations for plants adapted to our climate and water, but if the participants choose to follow through on the plan they can benefit from a discount of 60% on the cost of the plants !

Environment Committee Hard at Work

Fish Stocking - in 2008 \$3,290 was spent throughout the Domaine to stock fish. This amount was split between the Association's \$1500 budget allocation and \$1790 from contributions from fishermen from our lakes. Many Rainbow Trout were added to our waters. This variety was used because Rainbow generally don't reproduce in our lakes, so that as we re-stock each year we maintain the population balance for our sport fishermen.

Once again, it is important to note that the Environment Committee will continue to control and manage fish stocking throughout our lakes. There is too much danger for environmental damage if individuals take it upon themselves to bring fish in from outside lakes in "questionable" water. Invasive aquatic plants and organisms can be accidentally introduced to our waters and devastate our lakes' ecology, not to mention your home and cottage property. We don't want to have the problems that some surrounding lakes have had e.g. Lac St. Pierre and the milfoil problem!

Annual Water Testing - The Environment Committee and other volunteers completed testing of phosphate levels in our lakes in April 2009. Testing for e-coli occurred in August 2008.

Annual Tree Distribution – The Gatineau River Basin Committee and the Lievre River Basin Committee made 6,740 trees (eight different species) available to 14 lake associations through the Federation of lakes of Val-des-Monts. The PSLI Association received 700 trees which were distributed to eager members with shovels at the ready! Furthermore, this spring the Regional Municipality of the Collines received 4000 trees from the Quebec Ministry of Natural Resources. Your Association PSLI received 500 of these trees which were distributed to interested owners. If any of you would be interested in receiving free trees for purposes of rehabilitating your shoreline please let us know by e-mail info@psll.ca or contact your lake representative.

Good fishing but don't forget your fishing licence

ATTENTION ALL GARDENERS - YOU CAN DRIVE A STAKE INTO LAKE POLLUTION!


The more there are native shrubs on our shoreline the more lake water quality will improve. The roots of these shrubs act like a fine mesh net that intercepts pollutants and harbours beneficial bacteria to treat water. Shrub leaves provide cover for fish habitats, frogs and other creatures needing access to the lake.

A quick and simple way to build up your shoreline shrubbery is to "live-stake" – this means to insert cuttings from existing native shrubs into the soil without disturbing existing vegetation. This technique is best in the spring and or fall. The 5 "live-stake" steps are:

1. **Select a Shrub** – pick a shrub already on your property that is thriving
2. **Take cuttings** – with hand pruners, select stems that are thicker than your little finger and take no more than one-quarter of the healthy stems on the shrub. Cut the selected stems into 30-60 cm stakes. Remove side branches, twigs and leaves so that you have a relatively straight, bare stake. The top of the stake should be cut flat and the bottom end cut a 45 degree angle.
3. **Soak the Stakes** – To prevent the stake from drying out, soak the bottom ends in a pail of cold lake water for roughly 24 hours. Add a touch of rooting hormone to the water if you can – this really increases the chances of successful rooting. The rooting hormone should be one for woody hardwoods.
4. **Pick your Planting Site** – pick a spot where the new roots can intercept the most rain runoff and place the stakes near the water's edge so that when the shrub matures it will hang over the water and provide maximum habitat for the fish, frogs etc. . Use a sturdy rod, or rebar or an old screwdriver to make holes approximately 30 cm deep and 45 cm apart.
5. **Drive the stakes in** - push or gently hammer the stakes into place. Remember to keep the flat ends up and the angled end in the ground.

Next spring you should see leaves and branches sprouting from the base of most of the stakes. You can plant multiple stems at once and repeat over the years until your shoreline buffer is thick and luscious.

Boat owners with motors... have you got your Pleasure Craft Operator Card (PCOC) Yet?

In an effort to promote safe boating practices, all property owners who own motorized watercraft should be aware that PSSL will be fully supporting the Transport Canada regulations regarding the current and future requirements of operator cards for all powered pleasure craft. Currently, proof of competency is required if you fall into one of two categories:

1. You operate a pleasure craft fitted with a motor AND are born after April 1, 1983; or,
2. You operate a pleasure craft, fitted with a motor, that is under 4m (13 feet) in length (regardless of age).

If you were born before April 1, 1983 and operate a pleasure craft, fitted with a motor, that is 4 m and over in length, you will require proof of operator competency by September 15, 2009. These regulations apply to ALL pleasure craft with motors including rowboats, fishing boats, sea doo's, pontoons & cruisers etc...

As of September 15th, 2009 anyone wishing to use the PSSL boat launch on Lac Bataille, will be required to show proof of their pleasure craft operator card before being granted access. There will be no exceptions.

It should also be known that the MRC des Collines watercraft patrol have informed us that they will be visiting many lakes in VDM in 2009 and 2010 (including those within our domaine) to ensure that all motorized pleasure craft owners have their operator's card. Property owners are encouraged to report any unsafe boating behavior to the MRC des Collines Police at 819-459-9911. The Police have advised us that you do not have to provide your name when filing a complaint if you fear possible repercussion (please note the boat variety, colour, size and location if possible). Have fun on the water this summer and safe boating to all!

ATTENTION ALL BOATERS on Lacs Bataille and Rheume!

The number of concerns raised about careless and dangerous boating is increasing! Careless and dangerous boating occurs when boats cause massive wakes. Wakes can be minimized by

- taking off from your dock at a 90 degree angle to the shore - **DO NOT TAKE OFF PARALLEL TO THE SHORE**
- towing tubes and skiers in a straight line - **DO NOT DRIVE IN ENDLESS CIRCLES**
- skiers and tubers should **STAY IN THE MAIN CHANNELS**
- respect the posted speed limits of 10 k max. as per the map

The consequences of careless boating and resultant wakes are very serious and affect us all !

- Personal property (docks & boats) are being damaged
- Shorelines are eroding
- Enormous wakes create a serious safety issue - young children have been knocked off docks by the force of the wakes
- The wildlife (ducks and loons) are becoming endangered
- Residents using pedal boats and canoes are at risk
- swimmers in bays are at risk
- People trying to fish are affected.

Association PSLL believes that everyone on the two "boating" lakes deserves respect and consideration.. We are aware that there is a great deal of enjoyment from skiing and tubing and the serious problems outlined above can be eliminated if boaters

- Take off at a 90 degree angle
- Drive in a straight line and in the main channels
- Respect posted speed limits



6th Annual Water Quality Day

July 18, 2009, 10 to 12:30 am

Community Hall - Parc Thibeault (St. Pierre Sector)

The Federation of Lakes of Val-des-Monts in conjunction with the Municipality of Val-des-Monts will hold the 6th annual Water Quality Day on Saturday, July 18 2009. This year's event will be somewhat different from past years. The Federation has invited Mr. Pierre Brochu, well known in Quebec as a Director of film documentaries. He will present parts of his film entitled "Our Lakes Under the Surface" which were filmed in many of Quebec's lakes.

Another invited guest will be Mr. Louis-Marie Poissant., Master of Environmental Studies, of the Outaouais Department of Public Health who will speak about environmental health issues specific to the residents of Val-des-Monts. Other guests will be representatives from the municipality such as, for example, the Mayor, Mr. Jean Lafrénière and Mr. André Turcotte, Director of Environmental Services and Urban Planning.

Finally, Yann Gagnon, the new Coordinator from the Federation, will present water testing results for phosphate levels as well as talk about projects which the Federation of Lakes of Val-des-Monts has underway.

Interim Control By-Law for the Comprehensive Protection of Lakeshores and Watersheds

On March 19 2009, the Regional Municipality of the Collines de l'Outaouais adopted interim control by-law number 137-09. This by-law is aimed at reinforcing existing regulations about lakes and water course shoreline protection of up to five meters from the shoreline. This by-law is in keeping with the Province of Quebec's current and future direction on this subject.

On June 8 2009, André Turcotte, Director of Environmental Services and Urban Planning for the Municipality of Val-des-Monts informed members of the Federation of Lakes of Val-des-Monts (FDL-VDM) that, henceforth Municipal Inspectors will issue courtesy warnings when called to handle relevant complaints on this subject and they will focus on informing and educating residents about shoreline changes that are in keeping with municipal and provincial regulations. Mr. Turcotte also indicated that information about the new by-law will be published in local newspapers in order to inform residents at large. **There are significant changes to the regulations dealing with lakeshores and watershed so it will be important to look out for published information as it is made available especially if you are planning any such changes on your property.**

As of 2010, a visit from a Municipal Environment Inspector in response to a complaint will result in fines as follows: the first offence is a minimum fine of \$300 (maximum \$1,000) if the contravenor is a private individual or person. The fine increases to \$500 (maximum \$2,000) if the contravenor is a business enterprise or company. In the case of a repeat offence, the minimum fine will be \$500 (maximum \$2,000) for a private individual and then a minimum fine of \$2,000 (maximum \$4,000) in the case of a business enterprise or company. Mr. Turcotte also advised Federation members that shoreline building (development) permits will be issued at no cost if the development request conforms to the by-law requirements and good practices. Going forward, when the municipality receives a permit request for shoreline development, the Environment Inspector will go on site, assess the situation and advise if the permit can be provided.
